Federal Reserve Connect provides an automated connection for sharing ACH files with the Federal Reserve Bank. Rather than going online to manually download and upload your ACH files, receive your files through secure file transfer protocol (FTP) and in a format that easily loads into your account processing system.

Returns and originations are also transmitted automatically. When the Federal Reserve Bank acknowledges receipt of your files, File Exchange verifies and stores your acknowledgements. If you have an exception on one of your files, Federal Reserve Connect sends a notification so you can promptly deal with it.

Not only does the highly automated Federal Reserve Connect service save employees hours of manually handling ACH files, it decreases risk by reducing their exposure to sensitive customer or member ACH data.

Be Better Prepared for Audits

Through Federal Reserve Connect, you can view your entire ACH process from start to finish. At any time, you or your auditors can see files and verify that ACH files and acknowledgements are balanced. The solution verifies that all ACH data is in the proper format to meet federal regulations and stores your data and audit trail for six years.


