#### Accessible PDF

Fiserv provides an accessible PDF that is a fully tagged, electronic bill or statement to allow visually impaired customers to navigate the document with the use of accessibility software. It contains all large-print features. Customers can use their accessibility software application to magnify and read text on screen. It is shipped in a CD format.

#### **Audio**

Fiserv can present an audio format of a document, bill or statement using synthetic voices to create a listening experience for those who are visually impaired. The audio is created and shipped in a CD format.

#### **Braille**

Fiserv offers your customers access to their transactional documents in braille. We can transcribe materials in many languages, including English and Spanish. Our braille transcription process meets the standards of the Braille Authority of North America (BANA).

### **Electronic Text**

Fiserv offers bills, statements and other documents converted to electronic text. Any charts and graphs with accompanying data is turned in to text. The text is set to predefined link length to work with screen readers. Once the electronic text is created, it is shipped in CD format.

### **Large Print**

Adhering to federal guidelines regarding large type is vital for many of your customers to be able to see their account documents. At Fiserv, creating large print documents is more than simply increasing the font size. Leveraging global style guidelines, every detail of your overall document is reviewed to create a large print version that is easily readable for your visually impaired customers.
